20-07-2020 (Monday)	Display of Election Schedule (2020-2021) on Notice Board / website and submitted to the Regulator / Director General Trade Organization Islamabad.
22-07-2020 To 25-07-2020 Saturday (up to 3:00 pm)	Member Firms desiring to change their representatives may intimate changes regarding names of representatives to the Secretary General along with necessary proof of eligibility. (Within 3 days of display of the schedule).
28-07-2020 (up to 5:00 pm)	Display of Provisional List on notice board and on website of Chamber, all members eligible to vote along with their National Tax Number and Sales Tax Registration Number in case of Corporate Members, Name & CNIC Number of Representative. (Within 7 days of announcement of Election schedule).
04-08-2020 (Tuesday) Up to 5:00 pm	Members who have any objections to the entries in the voters list may send their objections in writing to Secretary General within 7 days of issuance of voter list.
11-08-2020 (Tuesday) Up to 5:00 pm	Secretary General shall within 5 days from receipt of objections intimate action on objections or changes from the last day of preceding clause.
18-08-2020 (Tuesday) Up to 5:00 pm	Any person aggrieved by the decision of Secretary General may make a representation within 3 Days to the Election Commission.
21-08-2020	Election Commission will decide cases of objections within 3 Days (including Friday).
24-08-2020 (Monday) 5:00 pm	Any person aggrieved by the decision of Election Commission may appeal to the Regulator with in 3 days.
03-09-2020 (Thursday) 5:00 pm	The Regulator shall decide the appeal with in 10 days and his decision in this regard shall be final.
05-09-2020 (Saturday) 05:00 pm)	a) With in 2 days of the decision of regulator Final List of Voters shall be displayed on notice board. b) Displayed at the website of Hyderabad Chamber of Commerce and Industry. c) The Final List of voters to be submitted to the Regulators / Director General Trade Organizations, Islamabad.
06-09-2020 to 09-09-2020 (Wednesday)	Within four days of issuance of final list of voters, any person who is eligible to contest the election for the vacant post shall send his nomination duly proposed and seconded by the registered voter and signed by the candidate to the Secretary General. (Nomination paper will be issued to contesting candidates on payment of Rs.5000/- only non refundable).
Note:	Final list of voters can be obtained by contesting candidates after filling nomination paper on payment of Rs.500/- (Non refundable)

10-09-2020 Thursday 6:00 PM	Nomination paper shall be scrutinized by the Election Commission and list of candidates shall be displayed with in 24 hours of last date of receipt of nomination papers.
12-09-2020 Saturday	Objections if any to nomination of Candidates can be filed to the Election Commission within 24 hours of issuance of final list of candidates.
15-09-2020 Tuesday 5:00 PM	Election Commission shall decide the cases within two days.
17-09-2020 (Thursday)	Within two days any aggrieved candidate may file appeal to the Regulator / DGTO Islamabad.
24-09-2020 Thursday	The Regulator / Director General Trade Organizations, Islamabad shall decide cases within 7 days and his decision shall be final.
26-09-2020 (Saturday) 5:00 PM	The Election Commission, shall issue the Final list of candidates within 2 days of decision of the Regulator. If no appeal has been filed to the Regulator the final list of candidates shall be issued within 11 days of the decision of Election Commission.
30-09-2020 Wednesday (From 9:00 am To 5:00 pm)	Polling for election of members of Executive Committee Shall be held in the premises of Hyderabad Chamber of Commerce & Industry. (within 5 days of display of final list of candidates, including Friday).
01-10-2020 Thursday (5:00 PM)	Any elected member of Executive Committee shall obtain and send his nomination for Election as office bearer (President / Senior Vice President and Vice President) duly proposed and seconded by an elected member, signed by candidate, to the Election Commission within 2 days of polling.
03-10-2020 (Saturday) (5:00 pm)	Nomination papers for office bearers (President and Senior Vice President and Vice President) shall be scrutinized by the election commission and final list of candidates will be displayed on notice board (within 24 hours).
05-10-2020 (Monday) (10:00 AM to 5:00 PM)	The polling shall be held for election of office bearers (President, Senior Vice President and Vice President) within 2 days of display of final list of candidates.
07-10-2020 (Wednesday 1:00 PM)	The final result of election of members of Executive Committee and office bearers (President, Senior Vice President and Vice President) shall be announced in the Annual General Body Meeting called for this purpose on 8 <sup>th</sup> October, 2020 at 1:00 PM sharp.
08-10-2020 (Thursday)	The Final Election Results announced in the Annual General meeting shall be displayed on notice board of the Chamber and will be displayed on the website of the Chamber.
15-10-2020 (Thursday)	The Election Results will be submitted to the Regulator / DGTO, Islamabad with in 7 days.
